### **DCD Helps With Lupton Project**

During the week of January 16, DCD took up the community project in Lupton again with taping and preparing for painting. This project is part of a series of community home repair projects that the Office of the President and Vice-President had committed to. Previously, the roofing installation, drywall installation for

However, because of winter weather, the construction activities had been put on temporary hold. The DCD team finished taping and "mudding" activities to get the walls ready for painting. ## **RESTRUCTURING OF THE NAVAJO NATION DIVISION OF COMMUNITY**

WINDOW ROCK – The Office of the President and Vice-President (OPVP) is pleased to announce the successful restructuring of the Navajo Nation Division of Community Development (DCD) that was approved by the Navajo Nation Resources and Development Committee of the Navajo Nation Council on October 25, 2016.

"We would like to congratulate Director Carl Smith for undertaking the huge task of restructuring his department. We are excited to achieve this huge milestone of OPVP and streamline processes within DCD. We support DCD and anticipate a lot of completed critical infrastructure projects in 2017," said President Russell Begaye.

This restructuring was made under the direction of the Navajo Nation Office of the President and Vice-President and Carl Smith, Director of the Navajo Nation Division of Community Development, to consolidate services provided by the divisions.

"This restructuring was made in response to the comments from local chapter officials to streamline services provided by the Capital Improvement Office, Design & Engineering Services Department, and the Solid Waste Management Department into one Capital Projects Management Department," said Vice-President Jonathan Nez.

This change will provide technical assistance, efficient direct services to all chapter officials, community service coordinators and accounts maintenance specialists.

Director Smith stated "Our department has been staffed with qualified and motivated individuals to provide support to the 110 chapters of the Navajo Nation. This restructuring was greatly needed to provide critical infrastructure and promote economic development for the Navajo Chapters."

The Division of Community Development was restructured into three working departments: Community Housing & Infrastructure Department (CHID), Capital Projects Management Department, and the Administrative Services Centers.



# **Torreon Senior Center Completed**



Recently, the CPMD department completed the construction of the new Torreon Senior Center. The project began with an initial award of \$1,500,000. Later, an additional \$495,000 was secured from the state of New Mexico as Phase I to complete the interior of the building. In Phase II, \$440,000 was secured from the state of New Mexico to complete the utilities, parking lot, and drainage. Mr. Leonard Hardy, Electrical Inspector, CPMD, was the project manager for this project. The project is 100% complete and is in the close-out stage. The building is expected to be occupied in spring of 2017.

This grant will provide funding for nine (9) powerline projects. The powerline projects are as follows:

The funding will assist 95 families with 45.27 miles of electric line in these chapter communities. Usually, this is the first time Navajo families get electrical services. The CDBG staff worked diligently in preparing this application. The last funding received was the FY-2015 in February of this year. Both 2016 and 2015 ICDBG awards were made back-to-back in the same year- 2016. Therefore, we are grateful for the chapters, families and NTUA for their efforts to receive such assistance.

# DCD Helps Deliver Food and Water to Families



On the night of Monday, January 23, 2016, Crystal Chapter staff were busy helping families in remote areas of the chapter by providing much-needed food and supplies. While they were out delivering food and water to several families, one of the 4x4 vehicles got stuck in the snow and mud.



The long stretch of dirt road that goes to the families goes through a wide valley that was already very muddy when the snowstorm came and dumped about a foot of snow with snowdrifts of up to 2 feet deep or more. The chapter took another vehicle to try to help the other 4x4 truck but both got stuck in the snowy, muddy mess.



The chapter reached out to DCD for assistance and Executive Director, Carl Smith, led a crew out to the scene on the morning of Tuesday, January 24, to try to get the vehicle out. The DCD crew, along with a large grader provided by NDOT, were able to get to the stranded truck and pull it out of the mud. The chapter staff were also using an ATV to deliver supplies to the worse areas. The DCD crew ferried supplies back and forth on the muddy road to the ATV so it could deliver on the final stretch to the families. The DCD crew also helped to deliver additional supplies and firewood to other families for the rest of the day.

On Thursday, January 12, 2017, newly elected Nazlini Chapter officials, Council Delegate Kee Allen Begay and Nazlini community members celebrated the purchases of a new backhoe loader and a tractor, which was purchased from the chapter's general funds.

# LOW MOUNTAIN LRAC HOSTS PUBLIC HEARING

January 10, 2017 at 10 am -- Low Mountain LRAC hosted a public hearing so that 22 roads & streets can be introduced to the community that will be used to establish physical addresses. NNAA provided guidance so that LRAC can get to this point; they identified which existing roads can be used for physical addressing.

The purpose is for E9-I-I implementation. After the Chapter approves a resolution next month to accept these road names (except BIA Roads, those will be adopted), this gives the green light to the Chapter to purchase sign materials. After signs are installed, NNAA can begin centerline dataset development so that physical address numbers can be generated for all the addressable structure points in the community that LRAC has identified (over 1250 address points)

Expressing one's affection to another is a celebrated custom on Valentine's Day. Sweethearts and family members present gifts to one another, such as cards, candy, flowers and other symbols of affection. Opinions differ as to who was the original Valentine, but the most popular theory is that he was a clergyman who was executed for secretly marrying couples in ancient Rome. In A.D. 496, Pope Gelasius I declared Feb. 14 as Valentine's Day. Esther Howland, a native of Massachusetts, is given credit for selling the first mass-produced Valentine's Day cards in the 1840s. The custon continues today with even young children exchanging Valentine's Day cards with their fellow classmates.



## If you're collaborating on a Google Doc, there are times you might want to jump on a phone call to discuss the content. You can easily create (and even record) free conference calls inside Docs.

The UberConference add-on for Docs is a simple, seamless way to get all your collaborators on a conference call right inside Docs, eliminating the need to switch between different programs.

- In Google Docs, head up to to Add-ons > Get add-ons. Search for UberConference, and then click Free button to install it. You will then have to allow the add-on to have access to your Google account.
- To start using your new add-on, head up to Add-ons > UberConference Sidebar > Show sidebar.
- A sidebar will open up on the right side of your screen. If your participants want to dial in using a phone, you'll see a phone number that people can call into. Once they call the number, they just need to enter the PIN number.

Other great features:

- Invite people directly to the conference call. You can enter in email addresses of other invitees, who will receive an email with a link to join. They can call in via telephone or computer.
- Record your conference call. This is a useful feature if you want to have a record of who made what suggestion during your teleconference, or if you need to refer back to it later.
- Share a file, screen, or window. In addition to sharing their screens, participants can also share files from Google Drive, their computer, Box, Dropbox, and Evernote.
- Receive call summaries. After your calls, UberConference will email you quick call summaries with the date, time, and duration of your calls, as well as participant information and statistics.

There is no upper limit to the free storage you can get and sky is the limit. (Many readers have found out that 'Copy' is a very insecure cloud storage service. Big thanks to all the commenters for notifying others the potential risks of 'Copy'.)

**5. ADrive:** ADrive gives you an impressive 50 GB of free cloud storage with personal accounts. But, with the free account you miss out on the best features of ADrive like 16 GB file uploads and also have to bear with the ads on Android and iOS apps.

**6. Bitcasa:** Bitcasa is a cloud storage service that lays emphasis on the privacy of your data. All data you store on Bitcasa is encrypted before upload and only you can view them. Bitcasa provides 20 GB of free cloud storage and you can access your data from 3 different devices.
