After our special appearances, it was time to eat a very good meal where the Hilton Garden Inn served Roast Beef, Mashed Potatoes, Vegetables, Salad, and Desert. When everyone was just about done eating, various employees drew names and exchanged presents with other employees.



NEW PROCESS FOR LIFELINE PHONE REGISTRATION



On Monday, December 18, 2017 members of the Universal Service Administrative Company (USAC) came to the Navajo Nation to meet with some of the chapters and Navajo Nation officials on new regulations regarding the Universal Service Lifeline program. The Lifeline program provides discounts to eligible customers for the cost of basic phone service and has been heavily used on the Navajo Nation.

The Federal Communications Commission recently passed some new regulations governing the Lifeline program that changes how the verification process works for Lifeline customers. Before, the phone companies could do the verification themselves. Under the new regulations, a national verifier must now provide the verification. USAC will be administering this national verifier role. The USAC team made the visit to the Navajo Nation to see how chapters were progressing with rural addressing. The team was able to visit St. Michaels Chapter and Oaksprings Chapter to get an understanding of how the chapters distribute information. They met with St. Michaels CSC, Donna Whitehair, and Vice President, Alfred M. Mike, Sr.

Later at NDOT Conference Center, USAC also met with various Navajo Nation departments administering social service programs to talk about partnering and data sharing. Navajo Nation President Russell Begaye was also present and spoke to how this might affect customers on the Navajo Nation.

President Russell Begaye turned over responsibility for the FBFA housing project to Division of Community Development several months ago. Since then, DCD has been working with the Navajo Housing Authority, Navajo Hopi Land Commission, and the 9 Chapters surrounding the FBFA to get homesites assessed and ready for construction. DCD contributed help in terms of Home



Assessments, Compiling Housing Material, and with the Procurement Process.

A ground

breaking ceremony for the first group of 36 modular homes was held recently. The Navajo Nation set aside more than \$3 million for construction and renovation of FBFA homes. Project Managers Carl Smith (DCD's Executive Director), Casey Begay (DCD's Department Manager), NHA's Construction Supervisor Ernest Franklin, and all 9 FBFA chapters Community Service Coordinators have been working closely with NTUA, Arizona Public Service, and Cholla Electric to get the FBFA project on its way to success.

Rural Addressing Training

On December 21, 2017, Navajo Nation Division of Community Development's Administrative Service Center (NNASC) and Navajo Nation Addressing Authority (NNAA) held a Physical Address Verification Training for NN chapters, where 35 people attended the morning session and 12 during the afternoon session. The Real ID Act that took effect in November 2016 for the state of New Mexico required private citizens to



provide two forms of proof of residency. So, both NNASC and NNAA joined alongside the Motor Vehicle Division (MVD) to

initiate a process that would be simpler, yet informative, called Physical Address Verification (PAV). This document would serve for purposes such as getting your license renewed. This simplified PAV process is provided to NN Chapters so the chapter can generate the second residency verification. The training focused on web resource mapping tools for providing these documents.

PRESIDENT BEGAYE SIGNS AGREEMENT **PROVIDING HOUSING SUPPORT TO** NAVAJO UNM STUDENTS

On Jan. 3, President signed off on an agreement with the University of New Mexico (UNM) to purchase the rights to occupancy of the Lobo Rainforest Building, a college dormitory space for 118 Navajo students.

"One of the primary reasons for the high college dropout rate for Native Americans is due to financial distress," President Russell Begaye said. "With student housing owned by the Navajo Nation, we can alleviate some of this burden off our students and support them in reaching their full potential."

In the agreement, the Regents of UNM grant the Navajo Nation the rights to occupy the entire fifth and sixth floors of the Lobo Rainforest Building. The agreement is for the term of three years and seven months starting on Jan. 1, 2018 and ending on Jul. 31, 2021.

PRESIDENT BEGAYE APPROVES \$2.4 MILLION FOR GRAZING, FARMAND LAND BOARDS

President Russell Begaye on Sunday signed a resolution awarding \$2.45 million from the Navajo Nation's Unreserved, Undesignated Fund Balance in stipends for officials serving on district grazing committees and farm boards, as well as the Eastern Navajo Land Board.

2020 Census Local Update of Census Addresses Operations (LUCA)

The 2020 Census LUCA registration deadline was Dec. 15, 2017. The LUCA registration deadline for areas impacted by the 2017 natural disasters has been extended to Jan. 31, 2018. Census Bureau Updates the Response Outreach Area Mapper Web Application


The U.S. Census Bureau will update the Response Outreach Area Mapper web application (formerly known as Low Response Score). This interactive tool identifies areas at the tract level that have historically been hard to count. It provides users with data visualizations that can be used to assist with planning, targeting and allocation of community resources. (Tentatively scheduled for release in January.)

Custodial Mothers and Fathers and Their Child Support: 2015


This report shows national-level trends of child-support income received by parents for children whose other parent(s) lived elsewhere. The Census Bureau collects detailed information about child-support agreements or awards, such as the reported amounts due and received, as well as other socio-economic characteristics about custodial parents and their families. 


WHAT ARE PLUS CODES?

A plus code is like a street address for people or places that don't have one.

Plus codes give addresses to everyone, everywhere, allowing them to receive deliveries, access emergency services, register to vote - and more.

Plus codes are short, simple, and easy to use: X4HP+M5, Cairo, Egypt, for example. These codes can be used on Google Maps to get directions to a home or business.





EASY TO USE

Places that are close to each other have similar plus codes. This makes it easy to work out if you are near to, or far away from your destination.



IDENTIFIABLE

The "+" symbol in plus codes helps identify them for people and computers, ensuring Google Search and Google Maps recognize them.

WHAT MAKES PLUS CODES UNIQUE?




FREE

Plus codes are free. There are no licensing fees or other costs. The technology is open-sourced.




ACCESSIBLE OFFLINE

You don't need a network connection: Plus codes work whether you are online or offline.



NON-EXCLUSIVE

Plus codes can be printed as a grid on paper, posters, and signs. This makes them useful also for people without access to mobile phones or computers.



INDEPENDENT OF BORDERS

Plus codes work in places that haven't been mapped. And they don't use country codes so they can even work in disputed territories.
