4. Current Status (as of August 2025)

- DPM electronic assessments and referrals remain in use
- Qualified applicants are sent directly to departments
- Departments initiate direct interview coordination

5. Challenges Identified

- Low application volume in remote areas
- Staff retention at Chapters
- Lack of structured training and orientation for new hires
- Public unfamiliarity with the new DPM hiring portal
- **Qualified applicants are referred, but communities and Chapters are not receptive to the referrals. This has resulted in continued vacancies despite having eligible candidates.**

6. Next Steps

- Continue recruitment and outreach efforts
- Collaborate with Chapters to advertise openings
- Provide applicant support and customer service
- Offer guidance and tech support for DPM portal navigation
- Educate local leadership on referral processes and hiring responsibilities
- Continue to align recruiting with the new ERP system with DPM

Conclusion

The recruitment process is progressing in line with Navajo Nation hiring standards and timelines. The electronic referral system has streamlined screening and

Division of Community Development has 5 Fiscal Recovery Staff who are working with the 110 Chapters (LGA & NON LGA) in ensuring timelines and funds are spent. They are also working with other entities on contracting the Bathroom Additions, Electrical Connection to Homes, Housing and Housing Manufacturing Projects.

OVERVIEW OF CJN 29-22

ARPA was created to address these 4 areas that were impacted by the COVID-19 pandemic.

1. To support the COVID-19 public health and Economic response by addressing Covid-19 and its impact on public health.
2. To provide premium pay to eligible workers performing essential work;
3. To provide government services up to the amount of revenue loss due to the pandemic;
4. To make necessary investments in water, sewer, and broadband infrastructure

ARPA OF CJN 29-22: SECTION 3

From January of 2024 to June 2024 a total amount of \$25,936,043.69 has been encumbered in 16 Sub Recipient Agreements with 14 LGA Certified Chapters

A total of 44 projects remain ARPA under the Delegate Regional Plans through a Subrecipient agreement are still subjected to Federal ARPA deadlines, regulations as well as the deadlines set by Navajo Nation Council, and the Navajo Nation Policies and procedures.

OVERALL CURRENT STATUS

Of the 44 SRA ARPA projects, fifteen (15) SRA ARPA projects have received 100% of the disbursements.

The team has been setting up meetings with certified chapters and began the monitoring and ensuring the projects are track and help with compliance. Going forward Wilson Stewart Jr., Department Manger, Ryan Begay, Planner/Estimator and Dawnell Begay, Planner/Estimator are beginning to conduct monitoring activities, and site visits for the 44 ARPA projects to ensure they are in compliance with both Federal Deadlines, Regulations as well as Navajo Nation Deadlines, Policies and Procedures.

Overview of Section 11

Resolution CJN-29-22, in Section 11, allocated ARPA/FRF funds for bathroom additions for each council delegate region. The Division of Community Development ARPA Office has been designated the project manager for the ARPA bathroom addition projects in November 2023, and has been working with the Indian Health Services Sanitation Facilities Construction, Navajo Tribal Utility Authority (NTUA) and Navajo Engineering & Construction Authority (NECA) to achieve the goal of construction of bathroom additions.

To date, DCD ARPA Office has issued forty-seven (47) work orders to NECA. Of these, Work Orders 1 through 15 have been fully completed,

We are pleased to report that we have completed - 340 bathroom additions since November 2023. Currently, 209-bathroom additions are in progress,

CO-41-24

Overall, we anticipate having over 500 bathrooms additions constructed across the Navajo Nation.

With the support of the 25th Navajo Nation Council, President Dr. Buu Nygren signed Resolution CO-41-24 on October 31, 2024. This resolution allocates an additional \$49,122,247.26 from unspent ARPA funds and amends the original Scope of Work to include Bathroom Renovation Upgrades.



The Delegate Regional Allocation remains equally distributed, with the number of clients served dependent upon on funding availability within each delegate Region*.

Bathroom Renovation Applications are being distributed by Ryan Begay, Planner/Estimator.

OVERVIEW OF RRR CMY 28-24

On June 17, 2024 CMY-28-2024 was signed in order to get the most from the Fiscal Recovery Funds, The legislation CMY 28-24 reallocates \$737.5 million to projects that have the highest likelihood of not being spent by the December 2026 deadline. The obligated projects include \$168,189,463.24 in Delegate Regional Plan monies. This funding goes into the Revenue Replacement Reserve fund (RRR). Eliminating ARPA federal deadlines for those identified projects.

CURRENT STATUS:

All Delegate Regional Projects previously legislated and approved by either Navajo Nation Council or the Naabik'iyáti' Committee are still intact in budget and scope of work. N Business Units have been established for these projects and are ready for expenditures.

Amendments to current legislated projects, at this time are to be requested to the chapters respective Delegate and the Delegate will follow the amendment process. The current ARPA/FRF Staff Ryan Begay, and Dawnell Begay, Planner Estimator's are managing the 352 RRR projects that are under the Section Delegate Region Expenditure Plans which encompasses all 110 chapters under the 24 Delegate Regions. Plesase see attached phase rollout plan for all approved/legislated RRR Projects. For the month of July the Division of Community Development ARPA/RRR Section 3 and Section 11 Project Managers Ryan Begay and Dawnell Begay along with Department Manager II, Wilson C. Stewart Jr. engaged with 25 Navajo Chapters across Western, Eastern, Fort Defiance, and Central Agency. The team also met with 5 of the 24 Delegates to discuss ongoing projects and community needs. JJuly 28-August 1, 2025 had been the busiest week as the FRF/ARPA Team continuously met with chapters and stakeholders. During the month of July , meetings were scheduled at the request of various chapters to discuss current project status updates for Section 3 and Section 11. Additionally some Local Governance Certified Chapters are in the process of pursuing Grant Agreements. They are taking the time to thoroughly understand the responsibilities involved in entering into a grant agreement to ensure they can effectively draw down funds directly to their chapters.

REPORT BY CAPITAL PROJECTS MANAGEMENT DEPARTMENT

CPMD Overview

The Capital Projects Management Department (CPMD) leads the planning, design, construction management, and oversight of public infrastructure projects across the Navajo Nation. Serving divisions, chapters, and affiliated entities, CPMD ensures projects meet community needs and long-term development goals.

Its core functions include securing and managing funding from tribal, state, federal, and other sources; preparing grant proposals and budgets; ensuring regulatory compliance; and managing contracts for construction and consulting services. The department oversees all project phases—design review, procurement, construction inspection, and closeout—while maintaining policies that guide prioritization, cost estimation, and scheduling.

With 16 staff members (10 in project management/compliance and 6 in support roles), CPMD handles contract administration, environmental and archaeological review, financial tracking, risk mitigation, stakeholder coordination, and reporting. Limited staffing, however, challenges its ability to meet the infrastructure needs of all 110 chapters. To address this, CPMD is working to expand staffing, improve processes, invest in professional development, and partner with leadership to advocate for sustained infrastructure funding.

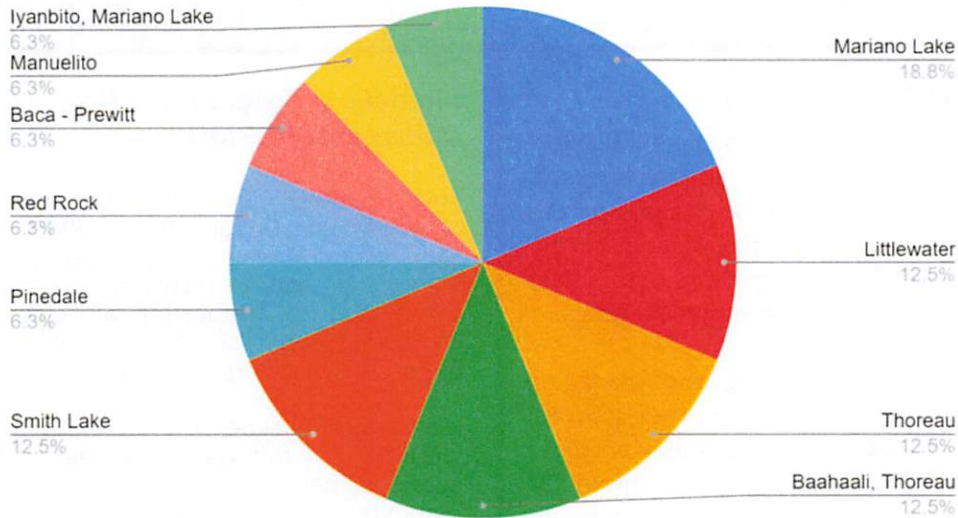

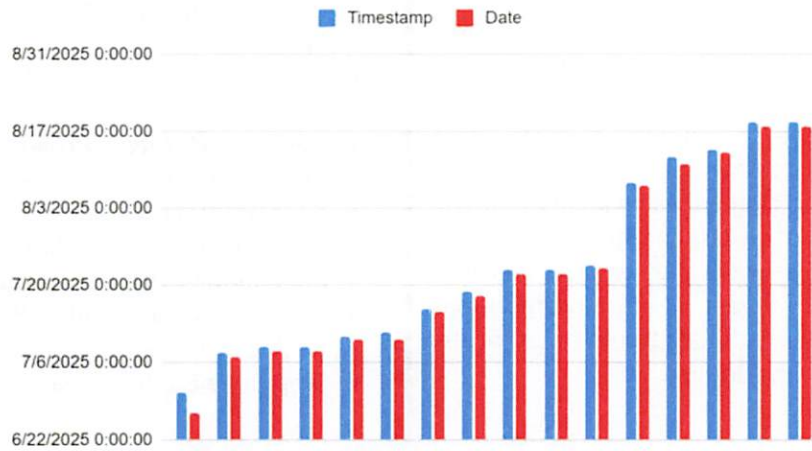
Overview of Outreach Efforts to Eastern Agency Chapters

Eastern Agency Chapters Assisted by CPMD Staff – Q4 Report

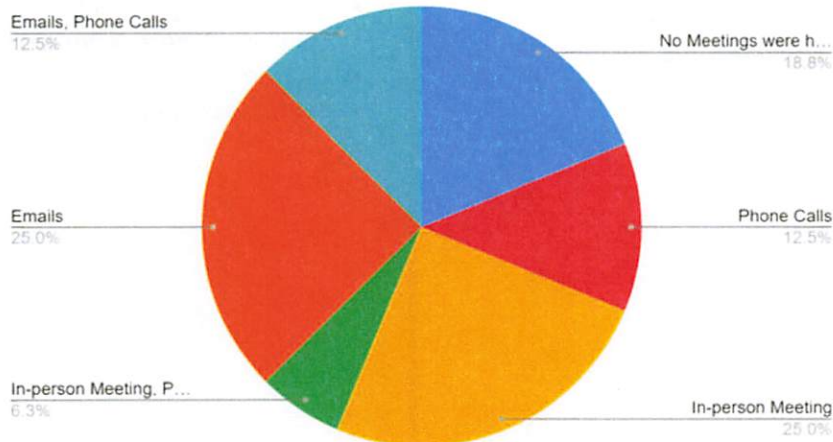


Staff Productivity & Performance Overview

Executive Summary

During the fourth quarter of FY2025, the Gallup ASC Office worked closely with chapters to ensure continued progress in critical areas of governance, financial compliance, and project implementation. The office completed multiple Five Management System reviews, facilitated land use planning updates, and advanced rural addressing projects to support community infrastructure. Gallup ASC also coordinated monthly staff meetings with all 31 chapters, addressed Corrective Action Plans and sanctions in several communities, and provided direct support where vacancies or staff shortages limited chapter operations. Despite challenges such as staffing gaps, reporting delays, and project funding constraints, the office maintained steady oversight and delivered key milestones, including successful allocation processing and enhanced collaboration with CPMD on chapter projects.

The Crownpoint ASC Office emphasized strengthening chapter governance and accountability through targeted initiatives such as policy review projects, chapter staff orientations, and the revival of reporting and community engagement practices. Notable accomplishments included completing all annual staff evaluations, ensuring ICIP updates across 16 chapters, and advancing financial reporting through annual allocations and carryovers. Crownpoint ASC also managed multiple CAP reviews and sanctions, while developing new tools such as an online tracking system to enhance transparency and accessibility for chapter staff and community members. Challenges remain in addressing high staff turnover, navigating ongoing allocation changes, and increasing community involvement, but the office continues to move forward with structured trainings, policy updates, and coordinated budget sessions to support the eastern agency's 31 chapters.

Crownpoint ASC Agency Report

Projects:

Chapter Reporting Program: Due to high attrition, ASC Crownpoint is initiating a project to revive the value in reports submitted to the nation. Emphasis will be for those reports that are available to the public for increased transparency and accountability. This project stemmed from the results of our Chapter Program Performance Reviews conducted at each chapter over the past two (2) quarters.

Chapter Community Involvement Project: The inception of this project began with complaints of outdated websites. The intent is to use the chapter websites as resources for chapter assistance programs, specifically scholarships, youth/public employment, housing discretionary and facility usage. The community members will then have consistent updates in chapter activities, deadlines, and meetings.

Chapter CLUPC Reinitiation: This ongoing project is intended to bring value back to the purpose and creation of the Land Use Plan, including emphasis on community cemeteries. Through this project, we hope to create a well-developed procedure for the appointment of committee members to encourage chapter trust and community involvement.

Chapter Policy Review Project: Through the performance reviews, ASC was able to identify which chapters' policies were outdated or had never formally passed policies for their chapter assistance programs. ASC will assist in hosting two (2) LGA Certified Chapters' Five Management System policy updates, and four (4) non-LGA Certified Chapters' Internal Policy Reviews. At some chapters, we will provide training on how to conduct policy reviews on their own.

Accomplishments:

Annual Appraisal for Chapter Staff: ASC Crownpoint successfully completed all non-certified chapter staffs' annual evaluations completed and submitted to the NN Department of Personnel Management.

Chapter Official & Staff Orientation: Through joint ASC Offices, we were able to provide a second orientation for the newly hired staff and officials at San Juan College in Farmington, NM.

Chapter Vacancies & Hires: We are consistently posting community announcements along with chapter staff and targeting local fairs for recruitment. ASO Cecelia Toledo is working diligently with new chapter staff on financial procedures and software training.

ASC Eastern Navajo Staff & Officials Meetings: With ASC Gallup, we are continually hosting monthly meetings to keep the chapters updated.

Goals:

ASC Online Tracking System: Create an online portal for the chapters to review status of their documents, job vacancy announcements and important updates by utilizing the ASC Crownpoint website.

Training: Develop proper training material and presentations for both chapter and community distribution.

Chapter Policies: Ensure that all chapters have updated policies, specifically their Five Management System & financial assistance policies. Published on all of their chapter websites.

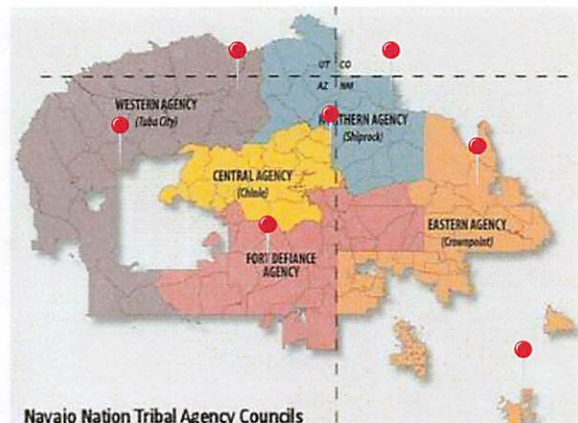
The CLUPC process involves setting both short- and long-term goals to promote balanced development and effective land management. Each Chapter has its own goals and priorities, so it depends on the status. Goals aim to address immediate priorities while fostering sustainable progress for future generations.

CLUPC plays a key role in assisting with community development, rural addressing, assessment compilations, and sections focused on solid waste management, contributing to the sections required and recommended.

Of the 110 Navajo Chapters, 96% have completed CLUPC orientations and implementation efforts. An orientation is crucial to have completed so it will enhance the overall goal effective planning.

Over the past year, several chapters have updated and recertified their land use planning manuals. As part of the process, DCD conduct training sessions for CLUPC committees on effectively utilizing resources and information to enhance their planning capabilities.

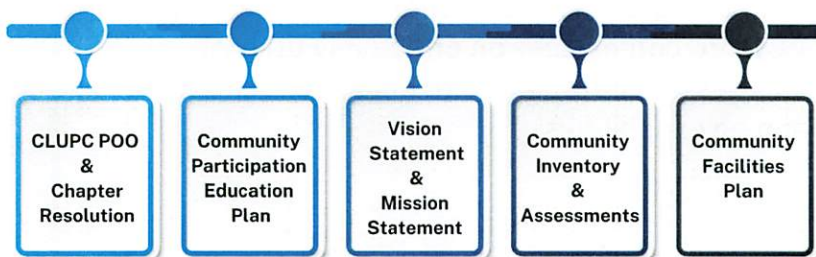
In August 2025, the Alamo Navajo Chapter hosted its strategic planning session, while the Community Land Use Planning Committee continued making significant progress on updating the Land Use Planning Manual. The committee has brought renewed energy and commitment to the process, working diligently to ensure the manual is completed accurately and on schedule. Most required sections are already finalized or in advanced stages of development, with only a few updates remaining. The goal is to have a fully updated, community-ready manual in place soon. Alamo is setting a strong example and leading the way forward.

According to the Navajo Nation Code Title 26, Section 2004, specific steps are required for updating and recertifying the Community-Based Land Use Plan. The CLUP's Plan of Operation must be approved along with the Chapter Resolution. The Community Participation and Education Plan must be finalized to ensure meaningful community engagement (list all your meetings with dates).

Additionally, the chapter's vision and guiding principles should be reviewed, updated, and completed. All chapter projects must be included in the Community Inventory Plan, accompanied by the necessary supporting documents. Lastly, the Community Facilities Plan must be incorporated as a required component. Following these steps is essential for successful recertification.

The CLUPC Orientation is guided by the Navajo Nation Code Title 26 requirements, Section 2004.

Solid Waste Program Update Report

The Division of Community Development (DCD) Solid Waste Program has been meeting with chapters across all Navajo agencies to provide updates and guidance on ongoing efforts. During these meetings, chapters have been advised on the following key points:

1. **Support with Roll-Off Bin Services**

- Assistance has been provided to chapters in obtaining quotes for roll-off bins to better manage waste services.

2. **Integration into Chapter Plans**

- All chapters are encouraged to work closely with their Community Land Use Planning Committee (CLUPC) to ensure that Solid Waste is incorporated into their community land use plans.
- Continue to develop a Comprehensive Plan for the overall of all 110.

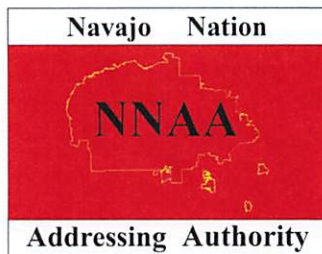
3. **Use of Allocation Funds**

- Chapters have recently received funding specifically designated for solid waste services. These funds can be applied toward monthly roll-off bin pulls.
- This allocation was a **one-time funding opportunity**, based on the "50/50 formula," which considers the number of registered voters in each chapter to determine funding distribution.

4. **Previous Technical Assistance**

- In 2024, several chapters received financial support from the Division of Community Development (DCD) and the Solid Waste Program to help pay their overdue solid waste invoices. This support was also a **one-time allocation**.
- Continue to provide technical assistance to all 110 chapters regarding solid waste.
- Continue with community outreach services; recycling, illegal dumping, proper waste management.
- Collaborate with governmental entities and non-profit organizations.

Overall, the Solid Waste Program continues to assist chapters in strengthening their waste management efforts, ensuring that resources are used effectively, and promoting cleaner communities through proper planning and collaboration.

EXECUTIVE SUMMARY

The Community Housing & Infrastructure Department (CHID) is committed to enhancing the living conditions of Navajo families by providing critical housing assistance through restoration and assessment services. On an annual basis, CHID assists eligible applicants with emergency relief efforts that include home assessments, provision of building materials, and workforce support to repair and renovate homes impacted by severe weather and other conditions. These services aim to ensure safe, livable environments for vulnerable households across the Navajo Nation.

The Housing Improvement Program (HIP) operates through an annual BIA 93-638 funding allocation. In collaboration with Chapter communities, HIP conducts outreach to distribute and collect BIA housing applications. Eligible applications are submitted to the BIA Navajo Regional Office for funding consideration. The program's primary goal is to raise housing standards by delivering essential repairs, renovations, and new housing construction for low-income families, in accordance with eligibility requirements outlined in 25 CFR Part 256.

The Indian Community Development Block Grant (ICDBG) program is a competitive federal grant funded by the U.S. Department of Housing and Urban Development's Southwest Office of Native American Programs (SWONAP). ICDBG supports essential infrastructure projects, with a focus on extending powerlines and improving water and wastewater systems. However, the program continues to face significant challenges due to increased competition among tribes in the Southwest Region and recent regulatory shifts that prioritize housing rehabilitation over infrastructure. These changes have contributed to a notable decrease in funding for utility projects, despite infrastructure being a foundational element of sustainable housing development. Nevertheless, CHID remains dedicated to advocating for ICDBG funding and advancing its mission to improve the quality of life for Navajo communities through robust infrastructure and housing support.

1. Housing Funding Source and Distribution (ARPA)

- A. Navajo Nation Fiscal Recovery Funds (2.16 New Housing): \$50 million
 - \$50 million to DCD/CHID new housing (CJN-29-22)
- B. \$50 million equal distribution to the 24 Council Delegate Regions
- C. \$2,083,333 to each Delegate Region
- D. Additional \$50 million ARPA housing funds under CMY-28-24
- E. \$50 million equal distribution to the 24 Council Delegate Regions
- F. \$2,083,333 to each Delegate Region

Total ARPA Funds: \$100 million for New Housing under CJN-29-22 and CMY-28-24

2. Home Site Assessments

- In collaboration with linaa'Ba', Inc., CHID and lina'Ba' have begun and completed home site location feasibility assessments for Eastern Agency Chapters, to begin planning for the site preparation for the incoming new modular or manufactured home units.
- Utilities (electric, water/wastewater) are also being assessed for connections.

3. Applicant Listing and Priority Management

- CHID and linaa'Ba' have been consulting with Chapter Representatives and Delegates on the current status of the new housing construction, delivery and set up for each of the Chapters.
- lina'Ba' has been contacting Eastern Agency Chapters to schedule on site assessments to identify home set up locations. Requesting applicant and Chapter representatives to be in attendance, to relay important messages.
- CHID requesting Chapters to assist with road access clearing, removal of obstructed structures, site grading and leveling.
- Work Order #3 applicant selection letters have been mailed out and other Work Orders letters will be sent out to the housing applicants by mail. Non-selection letters will be mailed out at a later time.

5. Community Development Block Grant (CDBG) Projects

- CDBG does not currently have any projects in Eastern Agency. There were no proposal submitted from the Eastern agency area for FY'25 funding cycle. However, CDBG encourages Eastern Agency Chapters to start preparing proposals for the FY'26 funding cycle.
- Public Hearings for FY'26 is tentatively scheduled sometimes in February - April 2026.
- CDBG conducted public hearings for the FY'2019/20 amendment application, there were no proposals submitted by Eastern Navajo Chapters, however, project savings will assist CHID ARPA Housing constituents with powerline for all agencies.

6. Housing Improvement Program (HIP)

I have been conducting Outreach and housing application intakes throughout the Eastern Agency. I started by contacting the Chapters to have them schedule me to visit their community to conduct a presentation on the program criteria and requirements. My first scheduled visit started in January 27, 2025 and the last day to scheduled outreach is August 22, 2025. Doing all these visits and application intakes, I collected 198 applications. I have about 80% of completed applications and about 20% that still need supporting documents to be submitted to HIP. We have until September 30, 2025 to submit all missing documents.

Here is a rundown of the chapters that had reached out to. I always let them know I appreciate the invites and hope to get scheduled in again.

Housing Improvement Program will continue working diligently with the Eastern Agency Chapters to get as many applicants for Fiscal Year 2026. HIP will continue encouraging constituents to keep applying for the possibility of one day they might get a new home. Therefore, HIP keeps their open communication with the Chapters and do as many presentations and outreaches as possible or as requested. Below is the report from the Eastern Eligibility Technician.
