Coming from private industry, I quickly identified missing internal processes and inefficiencies. In response, we've taken key steps:

- Repositioned staff to improve workflow.
- Began tracking specific projects for each team member;
- Started organizing and securing Division records.

These changes mark a shift toward greater accountability, structure, and responsiveness. I want to be here and truly enjoy seeing projects come to life. Let's continue working together collaboratively to deliver the progress our communities deserve.

4. Current Status (as of June 2025)

- DPM electronic assessments and referrals remain in use
- Qualified applicants are sent directly to departments
- Departments initiate direct interview coordination

5. Challenges Identified

- Low application volume in remote areas
- Staff retention at Chapters
- Lack of structured training and orientation for new hires
- Public unfamiliarity with the new DPM hiring portal
- Qualified applicants are referred, but communities and Chapters are not receptive to the referrals. This has resulted in continued vacancies despite having eligible candidates.

6. Next Steps

- Continue recruitment and outreach efforts
- Collaborate with Chapters to advertise openings
- Provide applicant support and customer service
- Offer guidance and tech support for DPM portal navigation
- Educate local leadership on referral processes and hiring responsibilities
- Continue to align recruiting with the new ERP system with DPM

Conclusion

The recruitment process is progressing in line with Navajo Nation hiring standards and timelines. The electronic referral system has streamlined screening and interviews, but local acceptance and cooperation remain key to filling vacant positions.

Division of Community Development has 5 Fiscal Recovery Staff who are working with the 110 Chapters (LGA & NON LGA) in ensuring timelines and funds are spent. They are also working with other entities on contracting the Bathroom Additions, Electrical Connection to Homes, Housing and Housing Manufacturing Projects.

OVERVIEW OF CJN 29-22

ARPA was created to address these 4 areas that were impacted by the COVID-19 pandemic.

- 1. To support the COVID-19 public health and Economic response by addressing Covid-19 and its impact on public health.
- 2. To provide premium pay to eligible workers performing essential work;
- 3. To provide government services up to the amount of revenue loss due to the pandemic;
- 4. To make necessary investments in water, sewer, and broadband infrastructure

ARPA OF CJN 29-22: SECTION 3

From January of 2024 to June 2024 a total amount of \$25,936,043.69 has been encumbered in 16 Sub Recipient Agreements with 14 LGA Certified Chapters

A total of 44 projects remain ARPA under the Delegate Regional Plans through a Subrecipient agreement are still subjected to Federal ARPA deadlines, regulations as well as the deadlines set by Navajo Nation Coucil, and the Navajo Nation Policies and procedures.

Overview of Section 11

Resolution CJN-29-22, in Section 11, allocated ARPA/FRF funds for bathroom additions for each council delegate region. The Division of Community Development ARPA Office has been designated the project manager for the ARPA bathroom addition projects in November 2023, and has been working with the Indian Health Services Sanitation Facilities Construction, Navajo Tribal Utility Authority (NTUA) and Navajo Engineering & Construction Authority (NECA) to achieve the goal of construction of bathroom additions.

To date, DCD ARPA Office has issued thirty-nine(39) work orders to NECA. Of these, Work Orders 1 through 10 have been fully completed,

We are pleased to report that we have completed - 310 bathroom additions since November 2023. Currently, 238-bathroom additions are in progress,

CO-41-24

Overall, once we complete all Work Orders 1 through 34 we anticipate having over 500 bathrooms additions constructed across the Navajo Nation.

With the support of the 25th Navajo Nation Council, President Dr. Buu Nygren signed Resolution CO-41-24 on October 31, 2024. This resolution allocates an additional \$49,122,247.26 from unspent ARPA funds and amends the original Scope of Work to include Bathroom Renovation Upgrades.



The Delegate Regional Allocation remains equally distributed, with the number of clients served dependent upon on funding availability within each delegate Region*.

Bathroom Renovation Applications are being distributed by Ryan Begay, Planner/Estimator. *Not all delegate regions are eligible and all applications are subjected to funds availability.

OVERVIEW OF RRR CMY 28-24

On June 17, 2024 CMY-28-2024 was signed in order to get the most from the Fiscal Recovery Funds, The legislation CMY 28-24 reallocates \$737.5 million to projects that have the highest likelihood of not being spent by the December 2026 deadline. The obligated projects include \$168,189,463.24 in Delegate Regional Plan monies. This funding goes into the Revenue Replacement Reserve fund (RRR). Eliminating ARPA federal deadlines for those identified projects.

CURRENT STATUS:

To date 384 Business Units have been established for the Delegate Regional Projects that have been transitioned to the Revenue Reserve Replacement fund. All <u>Delegate</u>

<u>Regional Projects previously legislated and approved</u>

<u>by either Navajo Nation Council or the Naabik'íyáti'</u>

<u>Committee are still intact in budget and scope of</u>

work.

Amendments to current legislated projects, at this time are pending policies and procedures to be created for the RRR/521 Trust Fund.

GOING FORWARD:

The current ARPA/FRF Staff Ryan Begay, and Dawnell Begay, Planner Estimator's are managing the 352 RRR projects that are under the Section Delegate Region Expenditure Plans which encompasses all 110 chapters under the 24 Delegate Regions. Plesase see attached phase rollout plan for all approved/legislated RRR Projects. For the month of May, the Division of Community Development ARPA/RRR Section 3 and Section 11 Project Managers Ryan Begay and Dawnell Begay along with Department Manager II, Wilson C. Stewart Jr. engaged with 21 Navajo Chapters across Western, Eastern, Fort Defiance, and Central Agency. The team also met with 8 of the 24 Delegates to discuss ongoing projects and community needs.

In May, meetings were scheduled at the request of various chapters to discuss current project status updates for Section 3 and Section 11. Additionally some Local Governance Certified Chapters are in the process of pursuing Grant Agreements. They are taking the time to thoroughly understand the responsibilities involved in entering into a grant agreement to ensure they can effectively draw down funds directly to their chapters.

REPORT BY CAPITAL PROJECTS MANAGEMENT DEPARTMENT

The Capital Projects Management Department (CPMD) plays a vital role in planning, designing, and delivering public infrastructure across the Navajo Nation. Through comprehensive project oversight and construction management, CPMD supports tribal divisions, chapters, and affiliated entities, helping ensure that capital projects align with community priorities and long-term development goals.

The department secures and manages funding from tribal, state, federal, and other eligible sources by writing grant proposals, planning budgets, and submitting compliance reports. CPMD also develops and administers contracts for construction and consulting services, ensuring projects are delivered efficiently, on time, and in compliance with safety and regulatory standards.

CPMD manages all phases of project delivery—including design reviews, procurement, construction inspections, and closeout—while maintaining internal procedures that guide project prioritization, cost estimation, and scheduling. Its team of 16 professionals, including 10 project and compliance staff and 6 support staff, carry out a broad range of responsibilities such as financial tracking, archaeological and environmental review, risk mitigation, stakeholder coordination, and administrative support.

Despite their expertise, the team faces ongoing challenges due to limited staffing and growing infrastructure demands across all 110 chapters. Each chapter receives annual capital project allocations, often requiring different levels of technical assistance and compliance oversight.

To meet these demands, CPMD is working to expand staffing capacity, invest in training, and improve internal processes. The department also collaborates with tribal leadership and partner agencies to advocate for sustained investment in infrastructure planning, delivery, and long-term community impact.

Executive Summary:

The Fort Defiance ASC Agency continues to provide robust support and technical assistance to its 16 chapters, focusing on emergency preparedness, budget compliance, and infrastructure planning. Despite some chapters not completing their Emergency Management Plans, all have received templates and will be offered additional work sessions. The Oak Ridge Fire prompted effective emergency responses from four chapters, showcasing preparedness in action. Infrastructure efforts continue with nearly completed renovations at St. Michael and Oak Springs, funded by Sihasin and ARPA. All FY2025 chapter budgets have been approved, though Sales Tax budgets require revision to emphasize economic planning. Ongoing guidance and orientations are being conducted, with a focus on budget closeouts, ICIP, and Community Land Use Plans. Staff support will be limited from July 27 to August 1 due to a division-wide meeting. Several key positions remain vacant, with hiring efforts underway.

The ASC Dilkon office is focused on improving policy awareness and chapter operations amid challenges such as limited office space and staff vacancies. Notably, Whitecone Chapter remains under sanction, and efforts are ongoing to address staffing and compliance issues. Training and orientations have been conducted on topics including emergency preparedness, Five Management System policies, and Title 26. Budget challenges persist with outstanding allocations in Dilkon, Greasewood, Kindalichee, and Ganado. ASC Dilkon is also advocating for compensation policy review, as staff frequently work extended hours to meet the technical assistance needs of chapters. The agency is committed to developing improved financial training and monitoring systems to support chapter operations and fiscal responsibility.

Fort Defiance ASC Agency Report

Emergency Management Plans:

- All 16 Chapters have the Emergency Management Plans Templates. The Chapters will be provided additional Emergency Management Work-Session again due to most of the Chapters not completing the Emergency Management Plans.
- St Michaels, Oak Springs, Wide Ruins, and Klagetoh Chapters recently experience the Oak Ridge Fire which affected the four communities. All four Chapters did an excellent job in implementing their Emergency Preparedness.

Infrastructure Capital Improvement Plan (ICIP):

Additional ICIP overview is necessary for the Ft Defiance ASC Area Chapters.
 There are new leadership and staff to orientate for a better understanding of ICIP.

Chapter ARPA/RRR:

 Both St. Michael and Oak Spring Chapter Building Renovations are nearly completion. The two-building renovation were funded by the Sihasin and ARPA funds. Both Chapters should be back in their new renovated Chapter Building soon.

Budgets:

- All FY 2025 Chapter Budgets are approved for compliance. Request for drawdowns have been completed. There were some delays for some Chapters, but should be in the process of receiving the rest of the 2025 allocations.
- Other Chapter budgets have been reviewed and approved.
- The Navajo Nation Sales Tax budgets are pending. The Chapter Coordinators and Chapter Managers are advised to revisit the budgets. It is highly recommended to Chapters to re-focus on economic/business planning. Currently, the Chapters are budgeting the Chapter Overhead Cost. (i.e. Administrative Expenses)

Technical Assistance and Guidance:

- Ft Defiance ASC Area continues to provide Technical Assistance and Guidance on daily basis. TA and Guidance includes assisting the Chapters with their budgets and review for compliance; Personnel; Staff meetings; and other concerns that arise at the Chapter level. TA and guidance is provided through telephone calls, on-site visits, and through email.
- On June 16-18, 2025, Conducted the third Chapter Officials orientation at the San Juan College, Farmington, New Mexico.
- On June 25, 2025, Conducted the Fort Defiance ASC Area Chapter Staff in Wide Ruins Chapter, Wide Ruins, AZ.
- Future staff meetings and work sessions will be conducted in the month of August. FY 2026 Budget work-session will be scheduled. FY 2025 close out is around the corner. ICIP and Community Land Use Plan Committee orientation will be scheduled in the next few months.
- New Chapter Leadership are recommended to attain and use their new email addresses provided by the Division of Community Development. Information Technology Office. Our office can assist to provide the information.
- Ft. Defiance ASC Area Office will provide <u>limited</u> Technical Assistance and Guidance for the week of July 27, 2025 to August 1, 2025. Staff will be attending a Division Wide Meeting.

- Sawmill Chapter Interviews were conducted and a selection was recommended.

- Administrative Service Officer: Currently Advertised.

Challenges:

- Lacking an Administrative Service Officer makes addressing all chapter needs difficult.
- Lack of proper office space to conduct day to day business, or for chapters to visit.
- CR impact at chapter level.


The CLUPC process involves setting both short- and long-term goals to promote balanced development and effective land management. CLUPC plays a key role in assisting with community development, rural addressing, assessment compilations, and sections focused on solid waste management, contributing to the sections required and recommended.

106 CLUPC orientations have been completed to all the chapters. An orientation is crucial to have completed so it will enhance the overall goal effective planning.

Over the past year, several chapters have updated and recertified their land use planning manuals. As part of the process, DCD conduct training sessions for CLUPC committees on effectively utilizing resources and information to enhance their planning capabilities.

Updates from the Chapters

Among the chapters within the Ft. Defiance Agency, the Klagetoh Chapter has distinguished itself by successfully recertifying its Community-Based Land Use Plan (CLUP) in November 2022. This achievement reflects the chapter's commitment to strategic land management and sustainable development. The updated plan serves as a guiding framework for current and future land use decisions, ensuring that community needs, cultural values, and environmental considerations are balanced.



Implementation of the CLUP is actively underway at the chapter house, where it is being used to guide infrastructure projects, housing development, and land allocation in alignment with community goals.


Additionally, 15 chapters within the region have not had their Community-Based Land Use Plans or chapter manuals updated since the early 2000s. Outdated plans can hinder effective land use decision-making, limit access to development funding, and reduce the chapter's ability to respond to current community needs and environmental challenges.

Bringing these chapter manuals up to date will require coordinated efforts involving community input, technical assistance, and support from tribal programs and planning departments. The process will not only ensure compliance with current land management policies but also empower chapters to make more informed and strategic decisions that reflect the evolving priorities of their communities. Addressing this backlog is essential for promoting sustainable development, preserving cultural values, and enhancing the overall governance capacity of these chapters.

According to the Navajo Nation Code Title 26, Section 2004, specific steps are required for updating and recertifying the Community-Based Land Use Plan. The CLUP's Plan of Operation must be approved along with the Chapter Resolution. The Community Participation and Education Plan must be finalized to ensure meaningful community engagement (list all your meetings with dates). Additionally, the chapter's vision and guiding principles should be reviewed, updated, and completed. All chapter projects must be included in the Community Inventory Plan, accompanied by the necessary supporting documents. Lastly, the Community Facilities Plan must be incorporated as a required component. Following these steps is essential for successful recertification.

The CLUPC Orientation is guided by the Navajo Nation Code Title 26 requirements, Section 2004.

Purpose of Visit

The Solid Waste Management Program is assisting chapters across the Navajo Nation with cleaning up illegal dump sites. As part of this effort, eight chapters in the Ft. Defiance Agency received technical assistance and information on addressing illegal dumping.

Chapters:

- Oak Springs
- Houck
- Jeddito
- Cornfields
- Klagetoh
- Steamboat
- Wide Ruins
- Greasewood Springs

A presentation addressed illegal dumping, trash disposal, recycling, and related challenges. Cleaning up dump sites remains a top priority for many chapters moving forward.

What I Found

8 chapters recorded and documented:

- 145 illegal dump sites
- Took photos of each location
- Collected GPS coordinates to map each site

The trash at these sites included household waste, furniture, old appliances, and building materials. Many dump sites were found near homes, roads, and waterways, which can harm the environment and community health.

What We Talked About

Chapter officials and community members expressed frustration over widespread illegal dumping, especially near homes and public areas. Key concerns included the lack of clear rules or penalties and the need for more education and outreach on proper trash disposal.

Ft. Defiance Agency

All of the chapters I visited currently have roll-off bins provided by Navajo Sanitation Services. However, despite the availability of these bins, illegal dumping continues to occur in surrounding areas. This underscores the need for improved outreach, expanded access to waste services, and stronger enforcement measures.

During my visits, I encouraged chapters to promote the use of nearby transfer stations for proper disposal—particularly for bulky items that cannot be placed in bins. Increasing transfer station use can significantly reduce illegal dump sites over time.

I also stressed the importance of incorporating solid waste management into each chapter's Community Land Use Plan (CLUP). This includes designating land for future waste services such as transfer stations, bin sites, or recycling initiatives. Including solid waste planning in the CLUP enhances each chapter's ability to pursue funding opportunities and gain support for waste-related projects.

Next Steps

Now that we have data from 145 dump sites, the next steps include:

- 1. Coordinate information with Navajo Nation EPA
- 2. Working together to hire cleanup contractors
- 3. Find additional funding sources
- 4. Continue with outreach and education for the general public
- 5. Implementing the SWMP at the Chapter level

Conclusion

The support from local officials and community members shows that people care and want to improve their communities. This is just the first step. By working together, we can clean up these dump sites and make sure future generations have a cleaner and safer place to live.

- NAAD staff will continue to provide guidance for ARPA funded Chapters under CJN-29-22, section 3 for rural addressing tasks; navigating through the general funds / revenue replacement reserve (GF/RRR) is a team effort; five (5) Fort Defiance Navajo agency Chapters is section 3 ARPA funded recipients.
- Sawmill: initial ARPA funds amount is \$233,662; public hearing was conducted in July 2024 to approve road/street names; BIA Road right-of-way (R-O-W) clearance was granted and DCD-ARPA staff ordered the road/street signs; once the sign materials are delivered, local rural addressing committee (LRAC) will receive training for intersection sign installation among the 376 addressable structures

FORT DEFIANCE NAVAJO AGENCY COUNCIL REPORT

EXECUTIVE SUMMARY

The Community Housing & Infrastructure Department (CHID) is committed to enhancing the living conditions of Navajo families by providing critical housing assistance through restoration and assessment services. On an annual basis, CHID assists eligible applicants with emergency relief efforts that include home assessments, provision of building materials, and workforce support to repair and renovate homes impacted by severe weather and other conditions. These services aim to ensure safe, livable environments for vulnerable households across the Navajo Nation.

The Housing Improvement Program (HIP) operates through an annual BIA 93-638 funding allocation. In collaboration with Chapter communities, HIP conducts outreach to distribute and collect BIA housing applications. Eligible applications are submitted to the BIA Navajo Regional Office for funding consideration. The program's primary goal is to raise housing standards by delivering essential repairs, renovations, and new housing construction for low-income families, in accordance with eligibility requirements outlined in 25 CFR Part 256.

The Indian Community Development Block Grant (ICDBG) Program is a competitive federal grant funded by the U.S. Department of Housing and Urban Development's Southwest Office of Native American Programs (SWONAP). ICDBG supports essential infrastructure projects, with a focus on extending powerlines and improving water and wastewater systems. However, the program continues to face significant challenges due to increased competition among tribes in the Southwest Region and recent regulatory shifts that prioritize housing rehabilitation over infrastructure. These changes have contributed to a notable decrease in funding for utility projects, despite infrastructure being a foundational element of sustainable housing development. Nevertheless, CHID remains dedicated to advocating for ICDBG funding and advancing its mission to improve the quality of life for Navajo communities through robust infrastructure and housing support.

1. CHID ARPA Housing Funding Source and Distribution

- A. Navajo Nation Fiscal Recovery Funds (2.16 New Housing): \$50 million
 - Section 10: \$50 million to DCD/CHID new housing (CJN-29-22)

- D. Additional Council approved \$50 million ARPA housing funds under CMY-28-24

- In collaboration with linaa'Ba', Inc., CHID and lina'Ba' have begun home site location feasibility assessments for Ft. Defiance Agency Chapters, to initiate planning for the site preparation for the incoming new modular or manufactured home units.
- Utilities (electric, water/wastewater) are also being assessed for connections, with the partnership of the local utility providers.

Note: Utilities are not part of the legislation, but the CHID team will assist with connecting the applicant with a utility provider to set up their own account for services.

3. ARPA Applicant Listing and Priority Management

- CHID and linaa'Ba' have been consulting with Chapter Representatives and Delegates on the current status of the new housing construction, delivery and set up for each of the Chapters.
- lina'Ba' will be contacting Ft. Defiance Agency Chapters to schedule on site assessments to identify new home set up locations. Requesting applicant and Chapter representatives to be in attendance, to relay important messages.
- CHID requesting Chapters to assist with road access clearing, removal of obstructed structures, site grading and leveling.
- Work Order #3 applicant selection letters have been mailed out and other Work Orders letters will be sent out to the housing applicants by mail. Non-selection letters will be mailed out at a later time.

- April 1-30, 2025: Visited six (6) Chapters to conduct presentations and collected (13) HIP housing applications.
- May 1-30, 2025: Visited one (1) Chapter to conduct a presentation and collected (0) HIP housing applications.
- June 3-30, 2025: Visited six (6) Chapters to conduct presentations and collected (5) HIP housing applications.

There are no upcoming presentation/outreach scheduled for the Ft. Defiance Agency for July, though all Ft. Defiance Chapters have been notified by email that HIP is available to conduct presentation/outreaches at their request.

Housing Improvement Program was fortunate to receive additional funds from BIA/ARPA for applicants that were selected based on the BIA Housing Assistance eligibility criteria. The individuals have been applying for housing from 2017 to 2020, when the funds were received. Therefore, there are a total of seventy-six (76) eligible applicants that were selected to receive a two (2) or three (3) bedroom manufactured homes. There were sixteen (16) homes delivered to Ft. Defiance Agency as of May 2025.
