Design and Engineering Services has been the Lead Agency for the newly complete 6.6 million dollar Shiprock Youth Complex located on south side of Shiprock Bureau of Indian Affairs building. The building was constructed with grant funding from Navajo Housing Authority for Shiprock Dine' Youth Office and for the use of all youth located with the Northern Navajo Agency. The building was designed by Dyron Murphy Architects and constructed by Arviso Construction Company.





# AmeriCorps Aids Navajo Nation Addressing Authority

In December 2014, our Partners, the Apache County Recorder's Office, LeNora Fulton, apply for a grant and it was approved to help assist with collection of Apache County residential data. A group of fine young people from AmeriCorps NCCC (National Civilian Community Corps) of the Denver campus southwest region arrived on January 8, 2015 and our office and Apache County provided orientation and training on how to collect data.

The team went out in pairs and went door to door starting at the Fort Defiance community. They started by a little introduction to the homeowners and that the information is for Rural Addressing where Physical Addressing can be established and that later it will be linked with 9-1-1. They asked for the homeowner's name, mailing address, a landline, general home location, type of home structure, and any additional home description. The team also inputted the data that was collected in NNAA's mapping tool and also saw the finished Rural Addressing Project where street/road signs

and structure signs were installed in San Juan County, New Mexico chapters.

The first team (Fire 2) that was here collected about 4,000 residential data within the 6-weeks they were here covering Fort Defiance, Window Rock, St. Michaels, Hunters Point, and Oak Springs. The next team (Fire 6) that came in after orientating them began finishing up Oak Springs/Pine Springs and west on AZ 264 to Kin Dah Lichii, Ganado, Nazlini, Klagetoh, Burnside, and into Chinle. Again, the second group collected over 7,000 residential data. The next team (Water 1) will be starting in Chinle and working their way northward to the areas that haven't been covered. We're hoping that the Chapters will now continue with this project since the AmeriCorps kick-started this process.

"The team members learned to adapt to the culture around them and saw parts of this diverse country that often go overlooked. Fire 6 gained skills including but not limited to public speaking, map orientation, cartography, data collection, data entry into the Mapping Tool. Fire 6 also learned a great deal about the Navajo culture, history and tradition while being fully immersed on the reservation." - **Benjamin Bradley**, Fire 6 Leader

### **Administration**

The Administrative Service Centers, (ASC) is the newest program under the Division of Community Development of the Navajo Nation. On Thursday, June 26, 2014 the Resources and Development Committee unanimously voted 3-0 approving the Legislation 0139-14, "Amending the Plan of Operation for the Navajo Division of Community Development in N.N.C. §1453 and Approving a Plan of Operation for New Administrative Service Centers which will Replace the Local Governance Support Centers as Part of the Decentralization Project Plan".

The ASC Administration began operations on October 14, 2014 to provide technical assistance to the 110 Chapters on the Navajo Nation, from 16 ASC sites divided by (2) service areas;

- A. Crownpoint Administrative Service Area (51 Chapters)
- B. Chinle Administrative Service Area (59 Chapters)

The ASC program's purposes are to provide planning services and guidance to chapters specifically relating to project planning, infrastructure development, community land use planning, and guidance in the implementation of Five Management System and policies.

The goals of the Administrative Service Centers are to promote local governance to develop independent and sustainable communities, implement a project management system, promote Local Governance Act certification for chapters, assist chapters with Post- Local Governance Act certification needs, and enhance human resource and professional development.

# Capital Improvement Office

"The purpose and mission of the Capital Improvement Office shall be to provide the Navajo Nation Government with a formal mechanism for decision-making related to infrastructure development and capital improvement programming."

The Capital Improvement Office was

established in 1985 within the Division of Community Development under the Executive Branch. CIO serves as the Administrative and Monitoring Navajo Nation Office for all Capital Planning and Infrastructure Development Projects funded through Navajo Nation General Funds. Since 1985, the Navajo Nation Council has appropriated over \$ 100,000,000.00 for Capital Improvement Projects throughout the Navajo Nation. The CIO is responsible for the administration, coordination, and development of the Capital Improvement Plan which was passed in May 2014.

The Capital Improvement Plan is a six year plan that prioritizes Projects for funding based on a prioritization and proposal evaluation process. The Capital Improvement Budget is to be appropriated separately from the Annual Navajo Nation Operating Budget based on available funds. The Capital Improvement Budget is the first of the six year plan.

# **Design and Engineering Services**

The Design and Engineering Services Department is the department responsible for implementing public facilities capital development projects on the Navajo Nation. The daprtment was established under the Division of Community Development for the purpose of providing planning, architectural, engneering, surveying, technical services and construction administration to the chapters, Navajo Nation

Departments and Tribal enitities. The following are used: Schematic Design Services, Design Development Services, Construction Document Services, Bidding or Negotiation Services, Construction Contract Administration Services and Post Construction Services.

# **Community Housing and Infrastructure Dept**

Community Housing & Infrastructure Department (CHID) is under the Navajo Nation Division of Community Development and was established in 2008. The CHID department consists of four (4) Programs: 1. Community Development Block Grant, (CDBG) 2. Housing Improvement Program (HIP), 3. Native American Housing Assistance & Self-Determination Act (NAHASDA) and 4. Weatherization Assistance Program (WAP)

NNAA provides technical assistance, guidance, public assistance to all Navajo Nation chapters. Our office provides Rural Addressing (RA) Training and assist the chapters in their conduction of their Rural Addressing activities. We also collaborate with the surrounding counties as well. We rely on the chapters to do the ground-work and we continue to assist and support them in completing their RA projects. We also assist the public in providing them with documentation for Physical Address Verification to be used to apply for a Drivers License, a Loan, Tax Filing, etc.

## Solid Waste Management Program

SWM Program provides opportunities for Navajo Nation communities to develop proper solid waste management and recycling practices. The program also assists and provides guidance for communities' to develop viable and self-sustaining regional solid waste disposal systems, and to close existing landfills and illegal dump sites.

# Google's Secret to Hiring the Best People

In a WIRED article, Google's Senior Vice-President of People Operations, Lazlo Bock, shares some tools for making informed decisions when hiring.



#### **Work Sample Test:**

"The best predictor of how someone will perform in a job is a work sample test (29 percent). This entails giving candidates a sample piece of work, similar to that which they would do in the job, and assessing their performance at it... You can (and should) offer a work sample test to someone applying to work in a call center or to do very task-oriented work, but for many jobs there are too many variables involved day-to-day to allow the construction of a representative work sample."

#### **Tests of General Cognitive Ability:**

"The second-best predictors of performance are tests of general cognitive ability (26 percent). In contrast to case interviews and brainteasers, these are actual tests with defined right and wrong answers, similar to what you might find on an IQ test. They are predictive because general cognitive ability includes the capacity to learn, and the combination of raw intelligence and learning ability will make most people successful in most jobs. The problem, however, is that most standardized tests of this type discriminate against non-white, non-male test takers."

#### **Structured Interviews**

"Tied with tests of general cognitive ability are structured interviews (26 percent), where candidates are asked a consistent set of questions with clear criteria to assess the quality of responses. There are two kinds of structured interviews: behavioral and situational. Behavioral interviews ask candidates to describe prior achievements and match those to what is required in the current job (i.e., 'Tell me about a time . . . ?'). Situational interviews present a job-related hypothetical situation (i.e., 'What would you do if . . . ?'). A diligent interviewer will probe deeply to assess the veracity and thought process behind the stories told by the candidate."

#### Conclusion

"Research shows that combinations of assessment techniques are better than any single technique... The goal of our interview process is to predict how candidates will perform once they join the team. We achieve that goal by doing what the science says: combining behavioral and situational structured interviews with assessments of cognitive ability, conscientiousness, and leadership."
